



Data Use

Data Use is the ongoing use of data for program accountability, program improvement, and program operations.

State and local staff or representatives prepare data products to promote understanding of the data and inform decisionmaking.

DaSy Framework: Data Use, Quality Indicator 3

- What question are you trying to answer?
- What is the context in which this question is answered?
- How will your audience understand this question in this context?
- What is the purpose of this visualization and how will a visual help tell this story?
- Will this communication be effective without a visualization?
